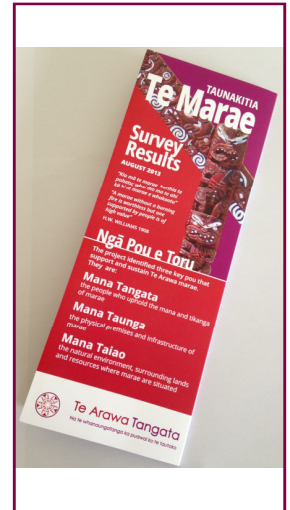

3 Taunakitia Te Marae – Marae Wellbeing Project Results

In September the Taunakitia Te Marae research project report was presented to the Marae Forum at Parawai Marae. It identifies seven tikanga whakahaere, cultural beliefs and values that guide practice and behaviour on the marae. These are Pūkenga; Honohono; Mana; Kaitiakitanga; Te Reo Māori; Tikanga-a-iwi, and Manaakitanga. These are supported by three key pou that help to sustain marae. The pou are Mana Tangata; Mana Taunga and Mana Taiao. The report provides a summary of the overall wellbeing of TPT affiliated marae that participated in the project and highlights areas for future development. i.e. succession planning, te reo Māori, rangatahi participation on the marae.

Te Arawa Tangata is now looking at how to support marae to identify opportunities to plan and implement collective solutions. The individual marae reports will be available to marae in December.



4 Te Arawa Rangatahi Tertiary Day

The Te Arawa Rangatahi Tertiary Day was held on 1 October at Apumoana Marae. This event was inspired by a suggestion from the Rangatahi Hononga to take the universities to our marae, an environment that is familiar and iwi friendly. The day included information on tertiary courses, career opportunities and education grants. The purpose was to encourage rangatahi to consider tertiary education and other career opportunities as their next stepping stone.

The event consisted of 12 tertiary & career providers, inspiring guest speakers, entertainment and fun interactive activities. Tertiary providers were impressed with the high level of engagement with rangatahi. Te Arawa Tangata plans to organise more of these types of events in the future.



5 Leadership Succession In Te Arawa

Coming soon – Rangatakapu Leadership Programme 2014.

This programme will aim to develop the skills of Rangatakapu (25 to 45 years) as part of a wider succession plan for emerging Te Arawa leaders. A key focus will be to develop leaders for roles within the local Te Arawa community. Participants will be required to make a one year commitment to the programme which will involve a series of marae based wānanga. The programme will inspire and empower potential leaders to actively contribute to the development of Te Arawa.
