New Chairperson

Unanimous agreement was reached at the meeting to revert to the original Trust Deed leadership model with the positions of Chair and Deputy Chair, rather than the Co-Chair model.

Te Pūmautanga o Te Arawa Trust (TPT) Background

In December 2006, TPT was established as a legal entity to receive, hold and manage settlement assets negotiated on behalf of its Iwi/Hapū Affiliates. TPT Iwi/Hapū Affiliates are: Ngāti Kearoa-Ngāti Tuara, Ngāti Uenukukopako, Tuhourangi-Ngāti Wahiao, Ngāti Tuteniu, Ngāti Pikiao, Ngāti Rongomai, Ngāti Tahu-Ngāti Whaoa, Ngāti Ngararanui, Ngāti Tarawhai, Ngāti Tura-Ngāti Te Ngakau, Ngāti Te Roro o Te Rangī.

TPT is the parent Trust with two subsidiaries, namely Te Arawa Group Holdings (TAGH) and Te Pūmautanga o Te Arawa Charitable Trust (TPTCT).

TAGH is a commercial company that has a long-term vision and mission of creating wealth and opportunity for future generations.

The Charitable Trust was formed in 2007 for charitable purposes to benefit Affiliate Te Arawa Iwi/Hapū. With rationalising TPT's business and also difficulties in obtaining sustainable external funding, TPTCT is now currently inactive. Nonetheless, we will keep an eye on opportunities should they arise.

Both subsidiaries are accountable to TPT.

Business Review

Over the previous 15 months our organisation has gone through a lot of change. To manage the business effectively, the Board has rationalised and restructured our operations.

Many staff resigned during 2015 because of uncertainty about TPT and TPTCT's future. Management had to focus on the core functions of TPT to try to reduce operational costs, so staff replacements were not made. Service providers were reviewed and we have found further ways to save costs.

We have transitioned our financial systems to a new automated system. We now have better access to information and have outsourced our financial support. Deloitte is providing financial and accountancy services, which has proven to be efficient and cost effective.

Mana Whenua

In June 2008, the Central North Island (CNI) Iwi Collective signed a final settlement with the Crown. The CNI Iwi Collective comprise of:

1. Ngāi Tahu
2. Ngāti Rangitahi
3. Ngāti Whakaue
4. Raukawa
5. Ngāti Manawa
6. Ngāti Tuwharetoa
7. Ngāti Whare
8. Te Pūmautanga o Te Arawa Trust

The CNI Iwi Collective agreed to a tikanga-based resolution process to settle claims to 23 Crown Forest Licenced Lands (CFLs), relating to 176,000 hectares.

Unfortunately, over the following six years iwi could not reach agreement, so the process went to adjudication. The CNI Iwi Collective engaged three Panel Members to adjudicate whose job it was to determine mana whenua in nine Kaingaroa CFLs.

It was up to each iwi to present evidence to the Adjudication Panel for their claim of mana whenua to each of the CFLs. TPT claimed mana whenua interests to nine of the CFLs, however in 2014 the Panel found that TPT had proven mana whenua interests in only four of these.

Discussions are progressing with CNI Iwi Collective under a kanohi ki te kanohi process. TPT is trying to reach written agreement for our allocation in the remaining CFLs where we have an interest.

TPT is focused on completing its mana whenua allocation agreements for CFLs before 1 July 2016.

Forestry scholarship

If you are enrolled as a full-time tertiary student in a forestry related discipline and have tribal affiliations to TPT, you may be eligible to apply for the Kaingaroa Timberlands Kaitiaki o te Ngahere Scholarship. This scholarship covers the total cost of tuition fees for a period of four years or less, with paid work experience offered during the holiday breaks.

Priority is given to applicants with tribal connection to Kaingaroa Timberlands forestry land and those who have lived in the central North Island for at least two years. Applications close 31 March 2016.
